

### **Estonian Ministry of Foreign Affairs auctions properties in Riga**

The Ministry of Foreign Affairs of the Republic of Estonia is selling at verbal auction an historic embassy building located in Riga, the capital of the Republic of Latvia (cadastral number 01000200115, total area 5 832.3 m², land plot area 1 261 m²) with starting price of EUR 4.5 million and also a plot of land in the city centre of 1 108 m² with a starting price of EUR 1.9 million.

The auction security deposit is 5% of the starting price of the auction.

The bid interval is EUR 10 000.





#### New residential area around seaside, near to Pirita Sailing Sports Centre

**Field:** Real Estate **Timeline:** in the next years

**Developer:** Liven AS **Value:** EUR 70 million

A 27 000 m<sup>2</sup> seaside property in the Pirita district will be developed into a modern residential area.

Liven plans to build three-storey buildings for 220 homes. 90% of the land will be for residential use and 10% commercial.

As a next step, Liven will organise an architectural competition which will include the surrounding beach promenade, respecting the wishes of the residents and following Liven's principles and standards.





### Arco Vara equity issue is aimed at residential property development

**Developer:** Arco Vara AS **Timeline:** 25.09.2021 - 15.10.2021

Value: EUR 2.25 million

Arco Vara's shareholders approved a proposal to launch a share issue aimed primarily at retail investors. The issue will raise EUR 2.25 million in additional capital, which the company will use to expand its development activities.

There is no pre-emptive subscription right, but Arco Vara said that new retail investors will have an advantage in the distribution.

The details of the offer will be set out in a prospectus to be published before the issue.

Arco Vara's share price has risen 75% this year to EUR 2.19.





# Viru Keemia Grupp explores the possibility of starting a bioproducts factory



The Viru Keemia Group (chemicals' business) is initiating a development planning process to explore the possibility of establishing a modern bioproducts production complex in Ida-Viru County, which would refine the pulpwood produced in Estonia and produce bioproducts and renewable energy.

The establishment of the new complex would increase the potential for wood refining in Estonia, partly replacing the export and incineration.

#### A new business center "Gustavs" in VEF Quarter



SIA "Gustava parks projekti", part of the Lithuanian "Galio Group" is going to build a new business center "Gustavs" in cooperation with construction company SIA "Merks". The business center will be built in Riga, Gustava Zemgala ielā 73 and will consist of three buildings – six-storey office buildings, as well as a two-storey underground car park and infrastructure.

The value of the construction contract is EUR 22 million and one of the three office buildings has already been rented by SEB group service center. The construction works are planned to be completed in December 2022.




# Additional shares of Madara Cosmetics will be traded on the stock exchange

Company: AS "Madara Cosmetics" Value: EUR 0.1

Starting August 3, the AS "Nasdaq Riga" stock exchange will start trading 1334 additional shares with a nominal value of EUR 0.1 of the cosmetics manufacturer AS "Madara Cosmetics". The shares will be traded in the alternative market "First North" in addition to the already traded shares of the company. As a result, a total of 3,770,576 shares of AS "Madara Cosmetics" will be traded.

In last year, Madara Cosmetics had a turnover of EUR 16.075 million, which is 39.2% more than a year earlier, while the company's profit increased 2.2 times and amounted to EUR 3.445 million.





#### A new office building in New Hanza



Construction of a new office building worth of EUR 26 million located in Riga, Mihaila Tāla Street 1 has been started by AS "Pillar Capital". The leasable area will reach 12,000  $m^2$ , but the total area of the building - 17 000  $m^2$ . Commercial premises are planned on the first floor of the building, of which 300  $m^2$  will be allocated to the catering service provider(s).

In addition, 96 parking spaces will be available, including with electric car charging points, as well as a bicycle parking lot for 330 bicycles and electric scooters will be available near the building. The construction works are planned to be completed by the end of 2022.






#### Valmiera concert hall for sale



A pearl of Vidzeme culture has been put up for sale – Valmiera Concert Hall. The building includes a concert hall with a capacity of up to 350 people, a conference/seminar center with a capacity of up to 60 people and Restaurant "Vecpuisis". The total area of the building is 1 301  $m^2$ , while area of the land is 7 359  $m^2$ . Sale price of the building is EUR 1.5 million.

The complex is located in the city center – Valmiera, Leona Paegles ielā 10. The building was built in 1914 as a public building and in 2016 it was reconstructed, preserving and emphasizing the historical values and significance of the building.



It is a concession tender for the design, construction, installation and maintenance of gyms (about 800 sq.m.), modular additional premises and engineering networks for the needs of Klaipėda University.

The sports infrastructure created at the risk of the private partner (except for the infrastructure intended for the needs of Klaipėda University) will remain in the ownership of the private partner after the end of the Agreement.





#### Palanga Airport launches modernisation construction project

On 6 September 2021, modernisation of Palanga Airport starts.

During the modernisation of Palanga Airport, a LED signal system will be installed, runway, taxiway and platform surfaces will be renovated. There will be upgrades to utilities. Energy-efficient and sustainable solutions, as well as systems of platform illumination, collection and purification of surface waste waters will further be installed.
